

**7PM Goal Horn Salute, presented by TD
(the “Contest”)**

RULES AND REGULATIONS

THIS CONTEST IS BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP (“VCLP”) IN COOPERATION WITH THE TORONTO-DOMINION BANK (“MARKETING SPONSOR”). NO PURCHASE IS NECESSARY TO ENTER OR WIN. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. PARTICIPATION IN THE CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE RULES AND REGULATIONS, AS THE SAME MAY BE AMENDED BY VCLP FROM TIME TO TIME IN ITS SOLE DISCRETION UPON NOTICE (POSTING AMENDED RULES AND REGULATIONS SHALL BE DEEMED TO BE SUFFICIENT NOTICE). ALL DOLLAR AMOUNTS ARE IN CANADIAN DOLLARS (\$CDN) UNLESS OTHERWISE NOTED.

(1) CONTEST PERIOD:

The Contest will begin at 9:00 AM (Pacific Time) on June 12, 2020 and end at 12:00 PM (Pacific Time) on June 26, 2020 (the "Contest Period").

(2) ELIGIBILITY:

In order to be eligible to win a prize, you must be a resident of the Province of British Columbia, at least 19 years of age, and must not be (and no member of your immediate family shall be) an employee of VCLP or any of its affiliates which collectively with VCLP operate as Canucks Sports & Entertainment (hereinafter “CSE”) or the Marketing Sponsor or any affiliate of the foregoing. Additionally, in order to be eligible to win four (4) of the eight (8) prizes, you must also have been a Canucks season ticket member (that is, the holder of a full season, half season or quarter season ticket package) for the 2019-20 Canucks season, as further described below. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to VCLP for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. VCLP reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

(3) HOW TO ENTER:

No Purchase Necessary. To enter the Contest, please follow these steps:

- using a web browser, go to Canucks.com/TDGoalHorn during the Contest Period; and
- follow the instructions to enter, including completing and submitting the official Contest entry form (and, if you were a Canucks season ticket member for the 2019-20 Canucks season, by entering your account number).

There is a limit of one entry per person during the Contest Period. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

(4) PRIZES:

In connection with each of the two (2) draw dates described below, there will be four (4) prizes available to be won (for a total of eight (8) prizes), consisting of the following:

- the opportunity to sound the goal horn at Rogers Arena at 7:00 pm in salute to healthcare workers, on a date designated by VCLP; Note: winners must be able and willing to travel to (and enter) Rogers Arena on the designated date, and must agree to abide by VCLP's health and safety directives, including completing a self-wellness check prior to entering Rogers Arena; and
- one (1) Canucks practice puck.

The approximate value of each prize is \$200. All other costs and expenses associated with the prizes, including without limitation transportation to and from Rogers Arena, parking (if required), travel insurance (if required), accommodations (if required), and items of a personal nature are the responsibility of the winner. All prizes will be awarded and are provided "AS IS" without warranty of any kind, express or implied.

(5) WINNER SELECTION:

Four (4) prize winners will be randomly selected from all qualified entries as of 12:00 PM (Pacific Time) on each of two (2) draw dates, as follows: June 19, 2020; and June 26, 2020. In connection with each draw date, two (2) prize winners will be randomly selected from all qualified entries who were Canucks season ticket member for the 2019-20 Canucks season, and two (2) prize winners will be randomly selected from all other qualified entries.

Any potential winner will be contacted via phone or email within the first twelve (12) hours following their random selection. Odds of winning a prize depend on the number of entries received prior to the 12:00 PM deadline for each respective draw. Entries will carry over from one prize selection to the next, except that no entrant shall be eligible to win more than one prize.

A selected entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by VCLP and to confirm his/her eligibility. A selected entrant must also agree to sign and return VCLP's standard Declaration and Release Form before being eligible to receive a prize.
