

**Air Canada Fan Flight Playoffs 2020 X Vancouver Canucks Contest
(the “Contest”)**

RULES AND REGULATIONS

THIS CONTEST IS BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP (“VCLP”). NO PURCHASE IS NECESSARY TO ENTER OR WIN. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. PARTICIPATION IN THE CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE RULES AND REGULATIONS, AS THE SAME MAY BE AMENDED BY VCLP FROM TIME TO TIME IN ITS SOLE DISCRETION UPON NOTICE (POSTING AMENDED RULES AND REGULATIONS SHALL BE DEEMED TO BE SUFFICIENT NOTICE). ALL DOLLAR AMOUNTS ARE IN CANADIAN DOLLARS (\$CDN) UNLESS OTHERWISE NOTED.

(1) CONTEST PERIOD:

The Contest will begin at 12:00 PM (Pacific Time) on August 12, 2020 and end at the conclusion of the last Vancouver Canucks playoff game during the NHL’s 2020 Return to Play (the “Contest Period”), whether that be in Round 1, Round 2, Round 3 or Round 4 of the 2020 Stanley Cup® Playoffs.

(2) ELIGIBILITY:

In order to be eligible to win a prize, you must be a resident of the Province of British Columbia, at least 19 years of age, and must not be (and no member of your immediate family shall be) an employee of: VCLP or any of its affiliates which collectively with VCLP operate as Canucks Sports & Entertainment (hereinafter “CSE”); Air Canada, the prize supplier for the Contest (the “Prize Supplier” or “Air Canada”); the National Hockey League (“NHL”), its member clubs, NHL Enterprises, L.P., NHL Enterprises Canada L.P., NHL Enterprises B.V., NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities, collectively, the “NHL Entities”); or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to VCLP for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. VCLP reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

(3) HOW TO ENTER:

No Purchase Necessary. To enter the Contest, please follow these steps:

1. Using a web browser, go to www.canucks.com/ACfanflight.
2. Complete and submit the official Contest entry form, including by nominating someone you think has had a positive impact on their local British Columbia community during COVID-19. Note: Your nominee must meet the eligibility requirements described above.

There is a limit of one entry per person during the Contest Period. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

(4) PRIZE:

There will be one (1) prize available to be won, consisting of the following:

- two (2) tickets to a Vancouver Canucks regular season away game during either the 2020-21 season or the 2021-22 NHL season, as selected by Air Canada and VCLP in their sole discretion;
- two (2) Economy class round-trip tickets for the prize winner and one (1) guest onboard any flight operated by Air Canada (including, flights operated under the Air Canada Express banner and operated by Air Canada Rouge) from the major Canadian airport served by Air Canada closest to the winner's place of residence OR Vancouver International Airport to the city where the selected NHL game will be played. Specific seat selection is in the sole discretion of Air Canada. Exact dates and times of flights will be determined by the Air Canada; and
- a two-night stay in a 3-star hotel or higher at a hotel in the city where the selected NHL game will be played, as designated by Air Canada in its sole discretion (one (1) room based on double occupancy).

Prize delivery timing will be determined by the Prize Supplier and VCLP in their sole discretion based on the Vancouver Canucks schedule and flight availability, all subject to applicable governmental and public safety requirements and recommendations.

The prize winner and his/her guest understand and acknowledge the risks related to the spread of infectious or contagious diseases and that it remains their responsibility to respect applicable governmental and public safety requirements and recommendations and take the necessary precautions applicable to any health hazards, including but not limited to COVID-19. By entering the Contest, each eligible participant acknowledges and agrees that the Contest is in no way administered by Air Canada or any of its subsidiaries and affiliates, and that VCLP is fully responsible for the conduct and administration of the Contest, including the selection of winners.

(5) WINNER SELECTION:

On or around the end of the Contest Period, the prize winner will be selected by a VCLP panel who will review and judge submissions from all eligible entrants based on the following evaluation criteria: the content of the submission, including the ability to demonstrate/showcase how the entrant's nominee has had a positive impact on their local British Columbia community during COVID-19.

Odds of winning a prize depend on the number of entrants who participate in the Contest and whether the VCLP panel selects your entry based on the criteria above.

A selected entrant must confirm that his/her nominee is available to participate in the prize. Further, the entrant and his/her nominee must agree to sign and return VCLP's standard Declaration and Release Form.

If any selected entrant does not meet all of the Contest conditions, or does not reply within five (5) days of the initial documented contact attempt by VCLP, that entrant will be disqualified and VCLP shall be entitled to select a new entrant from amongst the remaining eligible entries in accordance with these Rules and Regulations.
