RULES AND REGULATIONS

(1) CONTEST PERIOD:

(2) ELIGIBILITY:

(3) HOW TO ENTER:

No Purchase Necessary. To enter the Contest, please follow these steps:

- 1. Using a web browser, go to canucks.com/RubberOnTheRoad;
- 2. Complete and submit the official Contest entry form, including the entrant's prediction of the total number of saves that Vancouver Canucks goalie(s) will make

during the following four (4) games: January 27, 2022 (vs. Winnipeg), January 29, 2022 (vs. Calgary), January 31, 2022 (vs. Chicago) and, February 1, 2022 (vs. Nashville) (the "Contest Games"). For clarity, the number of saves entered should be the entrant's prediction of the number of saves on a cumulative basis during all Contest Games.

There is a limit of one entry per person. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

(4) PRIZE:

There will be one (1) prize available to be won, consisting of:

- four (4) tickets to the Vancouver Canucks vs. Calgary Flames game being held at Rogers Arena on March 19, 2022

The approximate retail value of the prize is \$3,500.00. (5) WINNER SELECTION:

The prize winner will be randomly selected at the end of the Contest Period from among the entrants who correctly predicted the total number of Vancouver Canucks goalie saves during the Contest Games (the total number of Vancouver Canucks goalie saves during the Contest Games shall be based on official National Hockey League statistics for the Contest Games).
