RULES AND REGULATIONS

- 2. Complete and submit the official Contest entry form, including the entrant's prediction of the total number of saves that Vancouver Canucks goalie(s) will make

during the following three (3) games: February 25, 2020 (vs. Montreal), February 27, 2020 (vs. Ottawa) and February 29, 2020 (vs. Toronto) (the "Contest Games"). For clarity, the number of saves entered should be the entrant's prediction of the number of saves on a cumulative basis during all Contest Games.

There is a limit of one entry per person. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.
