The Douglas Contest (the "Contest")

RULES AND REGULATIONS

THIS CONTEST IS BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP ("VCLP") IN COOPERATION WITH PARQ VANCOUVER LIMITED PARTNERSHIP ("MARKETING SPONSOR"). (1) CONTEST PERIOD:

The Contest will begin at 12:00 PM (Pacific Time) on April 27, 2022 and end at 12:00 PM (Pacific Time) on May 11, 2022 (the "Contest Period").

(2) ELIGIBILITY:
