

**The Douglas Contest  
(the "Contest")**

**RULES AND REGULATIONS**

THIS CONTEST IS BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP ("VCLP") IN COOPERATION WITH PARQ VANCOUVER LIMITED PARTNERSHIP ("MARKETING SPONSOR"). NO PURCHASE IS NECESSARY TO ENTER OR WIN. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. PARTICIPATION IN THE CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE RULES AND REGULATIONS, AS THE SAME MAY BE AMENDED BY VCLP FROM TIME TO TIME IN ITS SOLE DISCRETION UPON NOTICE (POSTING AMENDED RULES AND REGULATIONS SHALL BE DEEMED TO BE SUFFICIENT NOTICE). ALL DOLLAR AMOUNTS ARE IN CANADIAN DOLLARS (\$CDN) UNLESS OTHERWISE NOTED.

**(1) CONTEST PERIOD:**

The Contest will begin at 12:00 PM (Pacific Time) on April 27, 2022 and end at 12:00 PM (Pacific Time) on May 11, 2022 (the "Contest Period").

**(2) ELIGIBILITY:**

In order to be eligible to win a prize, you must be a resident of the Province of British Columbia, at least 19 years of age, and must not be (and no member of your immediate family shall be) an employee of VCLP or any of its affiliates which collectively with VCLP operate as Canucks Sports & Entertainment (hereinafter "CSE") or the Marketing Sponsor or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to VCLP for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. VCLP reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

**(3) HOW TO ENTER:**

No Purchase Necessary. To enter the Contest, please follow these steps:

1. Using a web browser, go to <https://contests.canucks.com/TheDouglasContest>; and

2. Follow all instructions to enter, including completing and submitting the official Contest entry form.

There is a limit of one entry per person during the Contest Period. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

**(4) PRIZE:**

There will be one (1) prize available to be won, consisting of the following:

- One (1) night's hotel accommodation at The Douglas Hotel at Parq Vancouver (in a room with 1 king bed or 2 queen beds, based on double occupancy); and
- One (1) The Douglas Hotel \$50 in-room dining credit to be used during your stay.

The prize has an approximate total retail value of \$500. The prize must be redeemed in its entirety on a single occasion by June 30, 2022 and may not be amended or extended. Any outstanding balances will not carry forward beyond such single occasion or beyond such deadline. Blackout dates apply. All prize elements are subject to availability and are non-transferable. **(5) WINNER SELECTION:**

The prize winner will be randomly selected on or around the end of the Contest Period from all qualified entries. Any potential winner will be contacted via phone or email within the first week following their random selection. Odds of winning a prize depend on the number of entrants who participate in the Contest.

A selected entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by VCLP and to confirm his/her eligibility.

A selected entrant must also agree to sign and return VCLP's standard Declaration and Release Form before being eligible to receive a prize.

If any selected entrant does not meet all of the Contest conditions, or does not reply within five (5) days of the initial documented contact attempt by VCLP, that entrant will be disqualified and VCLP shall be entitled to randomly select a new entrant from amongst the remaining eligible entries in accordance with these Rules and Regulations.
