

**2019-20 Pharmasave Canucks Calendar Contest
(the "Contest")**

RULES AND REGULATIONS

CONTEST BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP ("VCLP") IN COOPERATION WITH PHARMASAVE DRUGS (PACIFIC) LTD. ("PHARMASAVE"). NO PURCHASE NECESSARY. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. PARTICIPATION IN THE CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE RULES AND REGULATIONS (AS THE SAME MAY BE AMENDED BY VCLP FROM TIME TO TIME IN ITS SOLE DISCRETION). ALL DOLLAR AMOUNTS ARE IN CANADIAN FUNDS (\$CDN) UNLESS OTHERWISE NOTED.

(1) CONTEST PERIOD:

The Contest will begin at 12:00 PM (Vancouver time) on September 9, 2019 and end at 11:59 PM (Vancouver time) on January 31, 2020 (the "Contest Period").

(2) ELIGIBILITY:

In order to be eligible to win a prize, an entrant must be a resident of British Columbia, at least 19 years of age, and must not be (and no member of his/her immediately family shall be) an employee of VCLP, Vancouver Arena Limited Partnership or Aquilini Food Services Limited Partnership (collectively operating as Canucks Sports & Entertainment, hereinafter "CSE") or Pharmasave or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to VCLP for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. VCLP reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

(3) HOW TO ENTER:

To enter the Contest, please follow these steps:

1. Purchase a 2019-20 Pharmasave Canucks Calendar at a participating Pharmasave location in British Columbia, Canada during the Contest Period.

2. Using a web browser, go to www.canucks.com/calendar and enter the correct number of differences there are between the “Real Fin” and “Imposter Fin” images on the “Spot the Differences” Contest page inside the calendar. Follow the instructions to enter, including completing and submitting the official Contest entry form.

There is a limit of one entry per person. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

To enter the Contest without purchasing a calendar, please write an essay of approximately 500 words in length describing what you believe it means to be a Canucks fan and mail your essay during the Contest Period to the attention of 2019-20 Pharmasave Canucks Calendar Contest, Attn: Marketing Manager, 89 West Georgia St., Vancouver, BC, V6B 0N8 and your entry will be entered in the Contest draws following the date that VCLP receives your essay.

(4) PRIZES:

There will be forty (40) prizes available to be won (five prizes for each of the Vancouver Canucks home games played at Rogers Arena during the 2019-20 season that are identified in the table below), each prize consisting of four (4) upper bowl seats (in locations designated by VCLP) to a regular season Vancouver Canucks home game played at Rogers Arena during the 2019-20 season. The approximate retail value of each prize is \$400.

All other costs and expenses associated with the prizes, including without limitation transportation to and from Rogers Arena, are the responsibility of the winner.

(5) WINNER SELECTION:

The prize winners will be randomly selected from all qualified entries as of 12:00 pm (noon) on each of five (5) draw dates, as follows:

All potential winners will be contacted via phone or email within the first week following their random selection. Odds of winning a prize depend on the number of entries received prior to the 12:00 pm (noon) deadline for each respective draw. Entries will carry over from one prize selection to the next, except that no entrant shall be eligible to win more than one prize.

A selected entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by VCLP and to confirm his/her eligibility. A selected entrant must also agree to sign and return VCLP’s standard Declaration and Release Form.

If any selected entrant does not meet all of the Contest conditions, or does not reply within five (5) days of the initial documented contact attempt by VCLP, that entrant will be disqualified and VCLP shall be entitled to randomly select a new entrant from amongst the remaining eligible entries.

Once a potential winner is determined, the winning entrant will be directed as to how to claim their prize, which will be delivered within a reasonable time.

(6) GENERAL RULES:

This Contest is void where prohibited by law and is subject to all applicable federal, provincial and municipal laws and regulations. All incidental costs and expenses not specifically referred to herein, including (without limitation) taxes shall be the sole responsibility of the prize winner.

By entering the Contest, entrants agree to release and hold harmless CSE, Pharmasave, the National Hockey League and its Member Teams, NHL Enterprises Canada L.P., and the respective governors, subsidiaries, affiliates, agents, directors, officers, employees and representatives of each of the foregoing (collectively, the "Released Parties") from and against any and all liability, damages or causes of action (however named or described) with respect to or arising out of: (i) entrant's participation in the Contest, (ii) the receipt or use of the prize(s) awarded therein, or (iii) the administration of the Contest and the distribution of the prize(s) awarded therein.

Prizes must be accepted as awarded and cannot be exchanged for cash or otherwise. Prizes are non-negotiable, non-transferable and non-refundable. No telephone contact or correspondence will be entered into except with a selected entrant.

VCLP reserves the right to substitute prizes of equal or greater value and/or to terminate, modify or withdraw this Contest, in whole or in part, at any time, without prior notice for any reason, including, but not limited to, viruses, bugs, tampering or other causes beyond VCLP's control which affect the administration, security, fairness or proper play of the Contest. In the event a substitute prize is awarded, such prize must be accepted as awarded and cannot be exchanged for cash or otherwise.

VCLP shall have the right to make all determinations relating to the Contest in its sole discretion. Subject to the foregoing, any controversy or dispute arising out of the conduct of this Contest shall be resolved in the courts of the Province of British Columbia applying the laws of the Province of British Columbia (and federal laws of Canada applicable therein), to which exclusive jurisdiction and law the entrants agree to submit as evidenced by their participation in the Contest.

(7) USE OF CONTEST INFORMATION:

By entering the Contest, entrants:

- consent to the collection by VCLP of all Contest information, including their personal information obtained through the Contest, for the purposes of running the Contest, contacting entrants with offers which may be of interest to them (provided they have opted to receive such offers on the Contest website) and for such other purposes as described in VCLP's privacy policy, which may be viewed at www.canucks.com; and

The Released Parties assume no responsibility for any error, omission, tampering, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or authorized access to, or alteration of entries.
