

**2022.2023 Pharmasave Canucks Pet Calendar Contest
(the “Contest”)**

RULES AND REGULATIONS

THIS CONTEST IS BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP (“VCLP”) IN COOPERATION WITH PHARMASAVE DRUGS (WEST) LTD (“MARKETING SPONSOR”). NO PURCHASE IS NECESSARY TO ENTER OR WIN. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. PARTICIPATION IN THE CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE RULES AND REGULATIONS, AS THE SAME MAY BE AMENDED BY VCLP FROM TIME TO TIME IN ITS SOLE DISCRETION UPON NOTICE (POSTING AMENDED RULES AND REGULATIONS SHALL BE DEEMED TO BE SUFFICIENT NOTICE). ALL DOLLAR AMOUNTS ARE IN CANADIAN DOLLARS (\$CDN) UNLESS OTHERWISE NOTED.

(1) CONTEST PERIOD:

The Contest will begin at 12:00PM (Pacific Time) on September 12, 2022 and end at 11:59PM (Pacific :Time) on January 31, 2023 (the "Contest Period").

(2) ELIGIBILITY:

In order to be eligible to win a prize, you must be a resident of the Province of British Columbia, at least 19 years of age, and must not be (and no member of your immediate family shall be) an employee of VCLP or any of its affiliates which collectively with VCLP operate as Canucks Sports & Entertainment (hereinafter “CSE”) or the Marketing Sponsor or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to VCLP for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. VCLP reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

(3) HOW TO ENTER:

No Purchase Necessary. To enter the Contest, please follow these steps:

1. Purchase a 2022-23 Pharmasave Canucks Pet Calendar at a participating Pharmasave location in British Columbia, Canada during the Contest Period.
2. Using a web browser, go to www.canucks.com/calendar and enter the correct number of Pets that appear throughout the entire 2022-23 Pharmasave Canucks Pet Calendar.. Follow the instructions to enter, including completing and submitting the official Contest entry form.

There is a limit of one entry per person during the Contest Period. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

To enter the Contest without purchasing a calendar, please write an essay of approximately 500 words in length describing what you believe it means to be a Canucks fan and mail your essay during the Contest Period to the attention of 2022-23 Pharmasave Canucks Pet Calendar Contest, Attn: Marketing Manager, 89 West Georgia St., Vancouver, BC, V6B 0N8 and your entry will be entered in the Contest draws following the date that VCLP receives your essay.

(4) PRIZES:

There will be thirty (30) prizes available to be won (five (5) prizes for each of the six (6) Vancouver Canucks home games played at Rogers Arena during the 2022-23 season that is identified in the table below), each prize consisting of four (4) upper bowl seats (in locations designated by VCLP) to a regular season Vancouver Canucks home game played at Rogers Arena during the 2022-23 season.

The approximate retail value of each prize is \$400. All other costs and expenses associated with the prizes, including without limitation transportation, travel insurance if required, accommodations if required, meals, taxes and items of a personal nature are the responsibility of the winner.

In the event that VCLP is unable to awarding any of the prizes due to a public health order which requires Vancouver Canucks home games to be played at Rogers Arena without fans in attendance, then VCLP will provide a substitute prize of equivalent value.

All prizes will be awarded and are provided “AS IS” without warranty of any kind, express or implied.

(5) WINNER SELECTION:

The prize winners will be randomly selected from all qualified entries as of 12:00 pm (noon) on each of four (4) draw dates, as follows:

All potential winners will be contacted via phone or email within the first week following their random selection. Odds of winning a prize depend on the number of entries received prior to the 12:00 pm (noon) deadline for each respective draw. Entries will carry over from one prize selection to the next, except that no entrant shall be eligible to win more than one prize.

A selected entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by VCLP and to confirm his/her eligibility. A selected entrant must also agree to sign and return VCLP's standard Declaration and Release Form before being eligible to receive a prize.

If any selected entrant does not meet all of the Contest conditions, or does not reply within five (5) days of the initial documented contact attempt by VCLP, that entrant will be disqualified and VCLP shall be entitled to randomly select a new entrant from amongst the remaining eligible entries in accordance with these Rules and Regulations.
