

**Titans Trivia Contest, presented by TD
(the "Contest")**

RULES AND REGULATIONS

THIS CONTEST IS BROUGHT TO YOU BY AIG ESPORTS LIMITED PARTNERSHIP ("AIGELP") IN COOPERATION WITH THE TORONTO-DOMINION BANK ("MARKETING SPONSOR"). NO PURCHASE IS NECESSARY TO ENTER OR WIN. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. (1) CONTEST PERIOD:

The Contest will begin at 12:01 AM (Pacific Time) on November 20, 2020 and end at 11:59 PM (Pacific Time) on December 3, 2020 (the "Contest Period").

(2) ELIGIBILITY:

In order to be eligible to win a prize, you must be a resident of the Province of British Columbia, at least 13 years of age, and must not be (and no member of your immediate family shall be) an employee of AIGELP or any of its affiliates which collectively with AIGELP operate as Canucks Sports & Entertainment (hereinafter "CSE") or the Marketing Sponsor or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

(3) HOW TO ENTER:

No Purchase Necessary. To enter the Contest, please follow these steps:

- 1- Follow the Vancouver Titans on Twitter (@vancouvertitans) each day, or whichever day(s) you wish to participate, during the Contest Period to see what trivia question has been asked; and
- 2- Using a web browser, visit www.vancouvertitans.gg/TDTitansTrivia and fill out the Contest entry form and include your answer to that day's trivia question. Note: the accuracy of the answer provided to the trivia question will not affect the validity of an entry.

There is a limit of one entry per person per calendar day during the Contest Period. If multiple entries are made in one calendar day, that person will be disqualified from winning a prize with respect to that calendar day. Potential winners may be required to provide AIGELP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

(5) WINNER SELECTION:

On November 27, 2020, each of the seven (7) prize winners for the calendar days November 20 through November 26, 2020 will be randomly selected from all qualified entries received during each such day. On December 4, 2020, each of the seven (7) prize winners for the calendar days November 27 through December 3, 2020 will be randomly selected from all qualified entries received during each such day.

Any potential winner will be contacted via email within the first week following their random selection. Odds of winning a prize depend on the number of entrants who participate in the Contest on the applicable calendar day of the Contest Period.

A selected entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by AIGELP and to confirm his/her eligibility

A selected entrant (or the parent or legal guardian of the selected entrant, where the selected entrant is under the age of majority) must also agree to sign and return AIGELP’s standard Declaration and Release Form before being eligible to receive a prize.
