RULES AND REGULATIONS

(1) **CONTEST PERIOD:**

Entries will be accepted only from a parent or legal guardian of the child acting on the child's behalf, and each prize must be claimed by the parent/legal guardian on behalf of the winning child. The children of employees of VCLP, any member of the TPDA or any of their affiliates are not eligible to enter.

VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. (3) **HOW TO ENTER:**

There is a limit of one entry per person, except that a parent/legal guardian may submit more than one entry if submitting on behalf of more than one child. Potential winners may be required

(4) **PRIZES:**

There will be nineteen (19) prizes available to be won (one prize for each of the below seventeen (17) Vancouver Canucks regular season home games played at Rogers Arena, one prize for one (1) Vancouver Canucks pre-season game played at Save-On-Foods Memorial Center in Victoria, and one prize for one (1) Vancouver Canucks pre-season game played at Abbotsford Centre in Abbotsford as identified in the table below):

- i. opportunity for the winning child to sit with the trainers on the Vancouver Canucks bench during the pre-game warm up;
- ii. opportunity for the winning child to partake in a pre-game behind the scenes tour of the trainers' areas;

The parent/legal guardian of each selected entrant will be contacted via phone or email within the first week following their random selection. Odds of winning a prize depend on the number of entries received prior to the 12:00 pm (noon) deadline for each respective draw. Entries will

carry over from one prize selection to the next, except that no child shall be eligible to win more than one prize.
