

**Toyota Tundra Tour Contest  
(the “Contest”)**

**RULES AND REGULATIONS**

THIS CONTEST IS BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP (“VCLP”) IN COOPERATION WITH TOYOTA CANADA INC. AND THE TOYOTA PACIFIC DEALERS ASSOCIATION (COLLECTIVELY, THE “MARKETING SPONSOR”). NO PURCHASE IS NECESSARY TO ENTER OR WIN. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. PARTICIPATION IN THE CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE RULES AND REGULATIONS, AS THE SAME MAY BE AMENDED BY VCLP FROM TIME TO TIME IN ITS SOLE DISCRETION UPON NOTICE (POSTING AMENDED RULES AND REGULATIONS SHALL BE DEEMED TO BE SUFFICIENT NOTICE). ALL DOLLAR AMOUNTS ARE IN CANADIAN DOLLARS (\$CDN) UNLESS OTHERWISE NOTED.

**(1) CONTEST PERIOD:**

The Contest will begin at 9:00 AM (Pacific Time) on February 12, 2022 and end at 3:00 PM (Pacific Time) on April 30, 2022 (the "Contest Period").

During the Contest Period, there will be twenty (20) separate challenge periods, each being the three (3) hour period between 12:00 PM (Pacific Time) to 3:00 PM (Pacific Time) on the following days:

- February 12, 13, 20, 26 and 27, 2022;
- March 5, 6, 12, 13, 19, 20, 26 and 27, 2022; and
- April 2, 3, 9, 10, 16, 23 and 30, 2022,

(each, a “Challenge Period”).

**(2) ELIGIBILITY:**

In order to be eligible to win a prize, you must be a resident of the Province of British Columbia, at least 19 years of age and must not be (and no member of your immediate family shall be) an employee of VCLP or any of its affiliates which collectively with VCLP operate as Canucks Sports & Entertainment (hereinafter “CSE”) or the Marketing Sponsor or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

VCLP shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and

other information requested by and supplied to VCLP for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. VCLP reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

### **(3) HOW TO ENTER:**

No Purchase Necessary. To enter the Contest, please follow these steps:

1. During the Contest Period, watch for Contest-related tweets from the official Vancouver Canucks Twitter account;
2. Go to specific Toyota dealership location identified in a Contest-related tweet during the Challenge Period identified in the tweet, and locate Contest activation team; and
3. Follow all instructions to enter, including completing and submitting the official Contest entry form.

There is a limit of one entry per person during each Challenge Period, for a maximum of twenty (20) entries during the Contest Period. Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

### **(4) PRIZES:**

There will be a total of twenty-one (21) prizes available to be won, as follows:

- There will be one (1) prize available to be won for each Challenge Period, each such prize consisting of a signed Vancouver Canucks name & number home jersey (a total of twenty (20) such prizes) (each, a “Challenge Period Prize”). Each Challenge Period Prize has an approximate retail value of \$500; and
- There will be one (1) grand prize, consisting of two (2) tickets for seats in the Champions Club at Rogers Arena for a Vancouver Canucks regular season home game at Rogers Arena on April 28, 2022 (the “Grand Prize”). The Grand Prize has an approximate retail value of \$1,000.

All other costs associate with the prizes are the responsibility of the winners (including, with respect to the Grand Prize, transportation to and from Rogers Arena, travel insurance (if required), accommodation (if required), additional food and beverage that is not included in the Champions Club, parking, taxes and items of a personal nature).

All prizes will be awarded and are provided “AS IS” without warranty of any kind, express or implied.

### **(5) WINNER SELECTION:**

The Challenge Period Prize winners will be randomly selected on or around the end of the

applicable Challenge Period from all qualified entries. Entries will carry forward from one Challenge Period to the next, provided that no entrant may win more than one (1) Challenge Period Prize. Any potential winner will be contacted via phone or email within the first week following their random selection. Odds of winning a Challenge Period Prize depend on the number of entrants who participate in the Contest up to and including the applicable Challenge Period.

Each qualified entry during the Challenge Periods up to and including the Challenge Period on April 23, 2022 (including the entries of winners of Challenge Period Prizes in connection with such Challenge Periods) will automatically qualify for the Grand Prize draw. The Grand Prize winner will be randomly selected on or around April 23, 2022 from all qualified entries. Odds of winning the Grand Prize depend on the number of entrants who participate in the Contest by the end of the Challenge Period on April 23, 2022.

A selected entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by VCLP and to confirm his/her eligibility.

A selected entrant must also agree to sign and return VCLP's standard Declaration and Release Form before being eligible to receive a prize.

If any selected entrant does not meet all of the Contest conditions or does not reply within forty-eight (48) hours of the initial documented contact attempt by VCLP, that entrant will be disqualified and VCLP shall be entitled to randomly select a new entrant from amongst the remaining eligible entries in accordance with these Rules and Regulations.

Once a potential winner is determined, the winning entrant will be directed as to how to claim their prize, which will be delivered within a reasonable time.

## **(6) GENERAL RULES:**

This Contest is void where prohibited by law and is subject to all applicable federal, provincial and municipal laws and regulations. All incidental costs and expenses not specifically referred to herein, including (without limitation) taxes, shall be the sole responsibility of the prize winner. All trademarks are the property of the respective owners.

To the maximum extent permitted by applicable law, by entering the Contest, you agree to release and hold harmless CSE, VCLP, the Marketing Sponsor, the National Hockey League and its Member Teams, NHL Enterprises Canada L.P., and the respective governors, subsidiaries, affiliates, agents, directors, officers, employees and representatives of each of the foregoing (collectively, the "Released Parties") from and against any and all liability, damages, claims, costs and expenses, including reasonable attorneys' fees, or causes of action (however named or described) with respect to or arising out of: (i) your participation in the Contest, (ii) the receipt or use of the prize(s) awarded therein, or (iii) the administration of the Contest and the distribution of the prize(s) awarded therein.

Prizes must be accepted as awarded and cannot be exchanged for cash or otherwise. Prizes are non-negotiable, non-transferable and non-refundable.

VCLP reserves the right to substitute prizes of equal or greater value and/or to terminate, modify or withdraw this Contest, in whole or in part, at any time, without prior notice for any reason, including, but not limited to, viruses, bugs, tampering or other causes beyond VCLP's control which affect the administration, security, fairness or proper play of the Contest. In the event a substitute prize is awarded, such prize must be accepted as awarded and cannot be exchanged for cash or otherwise.

VCLP shall have the right to make all determinations relating to the Contest in its sole discretion. Subject to the foregoing, any controversy or dispute arising out of the conduct of this Contest shall be resolved exclusively in the courts of the Province of British Columbia applying the laws of the Province of British Columbia (and federal laws of Canada applicable therein), to which exclusive jurisdiction and law the entrants agree to submit as evidenced by their participation in the Contest.

unauthorized access to or alteration of entries, or any injury, damages, claims, costs, and expenses arising in connection with any prize or from participation in the Contest.
